This gives the Architectural Committee adequate time to review these applications before the meeting. Applications with no deposit can be submitted via email: architecture@svla.com. If a deposit is required, an appointment can be schedule at svla.com or by scanning the QR code.
- Whenever you have completed a project and are ready for a final inspection please let us know with an
 email to <u>architecture@svla.com</u> and we come and inspect it or schedule a time to inspect it with you
 depending on if the project warrants the property owner being there.

There are also documents to help guide you in doing your project such as a new home check off sheet, a general form explaining the setbacks on your home, or a guide to high desert landscaping if you are not sure what kind of plants to plant.
