YARD SALES

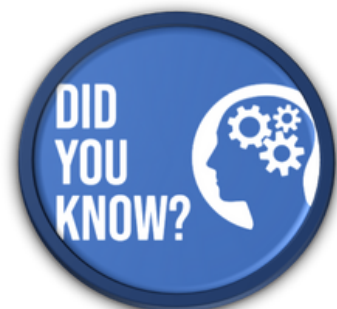
Any homeowner wanting to host a yard/garage sale must first obtain a permit from the Public Safety Department. Any person hosting a yard/garage sale without a permit could receive a citation.

Yard/Garage sales are limited to four per year, each limited to 3 days in duration, with a maximum of one in a 30-day period.
