Safety First!

From the Public Safety Department

Now that we are in the middle of the cold, winter months, be on the lookout for patches of ice. Black ice will most likely form on the parts of the road that are shaded by trees.

If you encounter black ice while driving, follow these tips:

- Keep the steering wheel straight
- Do not break - simply take your foot off the accelerator to slow down.

With boating season approaching, we want to remind all vessel operators to obtain their CA Boater Card. The CA Boater Card is required by state law for everyone aged 60 and younger. Beginning in 2025 the CA Boater Card will be required for everyone regardless of age.

Also, members who have non-powered vessels will now be required to have a non-powered vessel operators permit (V.O.P.). The V.O.P. test is about 10 questions long and focuses on the rules of our lake. The test and study guide are available on our website.
