10. SVL Country Club – Updates

Hurst gave an update on Invest SVL. The hope is to preserve and enhance the lifestyle of owners in Spring Valley Lake. Club Corp is selling the country club and approached the association to purchase. They felt it would be best if it was part of the association. After some research and much discussion, the Board felt it was also a good move. Fast forward to now and the association is in escrow with Club Corp. The next phase will be surveying the owners and going to a vote of the owners. A vote of 2/3 of the property owners is required to get a loan to purchase the country club. It has been a 2-year process to get to where we are. There are 3 parcels that the country club and golf coarse sit on and the association has no control over what happens to this property. Three meetings have been scheduled to share all the information regarding the country club purchase and Invest SVL. The meetings will be October 4th at 6:30 pm, October 5th at 2:00 pm, and October 6th at 6:30 pm.

Seven residents spoke in support of the skatepark. They feel it is very important to keep it in the plans for the park and include it with the Invest SVL plan.
